<b>HYGIENE</b>	<ul style="list-style-type: none"> <li>• Hand-sanitising stations in key areas of the venue</li> <li>• Personal hygiene products free to use</li> <li>• Hand washing facilities available</li> <li>• Enhanced cleaning regimes across all touch points, surfaces, and equipment</li> <li>• Cleaning checklists visible</li> <li>• Natural ventilation to rooms</li> <li>• Restricted guest toilets usage</li> </ul>
<b>SOCIAL DISTANCING</b>	<ul style="list-style-type: none"> <li>• Flexible rooms for social distancing including adjusted tables, chairs, and presentation layouts</li> <li>• Clear social distancing signage throughout</li> </ul>
<b>PPE &amp; FACE COVERINGS</b>	<ul style="list-style-type: none"> <li>• Stocks of disposable face masks available if required</li> <li>• Sanitary bins provided for used gloves, masks, and tissues</li> </ul>
<b>WELLNESS CHECKS</b>	<ul style="list-style-type: none"> <li>• A pre-screening questionnaire will be provided to the Event Organiser 24 hours prior attending. Details will be kept privately for 21 days and only used in case of any Covid-19 outbreaks</li> <li>• Guests asked not to attend the venue if displaying any Covid-19 symptoms, however mild</li> <li>• CityCo display a QR code system</li> <li>• CityCo will action a temperature check on arrival</li> </ul>

	<ul style="list-style-type: none"> <li>Attendees asked for contact details to support the Government Test &amp; Trace system. <b>PROTOCOLS</b>	<ul style="list-style-type: none"> <li>Dedicated Event Coordinator for all events who has full and relevant knowledge of H&amp;S and Covid-19 protocols</li> </ul>
<b>BOOKING GUIDELINES</b>	<ul style="list-style-type: none"> <li>Payment taken a week prior to any event</li> <li>Cash payments not accepted</li> <li>A full guide of 'How to use our Space' will be issued before any event. It is the responsibility of the Event Organiser to then communicate to all attendees</li> </ul>
<b>CANCELLATION FEE</b>	<ul style="list-style-type: none"> <li>As part of CityCo's Hire Agreement, neither party will be deemed in breach or otherwise liable to the other party, for any breach of its obligations resulting from an 'Event of Force Majeure'</li> <li>The operation of CityCo's Hire Agreement will be suspended during the period in which any 'Event of Force Majeure' continues, and any time periods will be extended accordingly</li> <li>If the Event Organiser wishes to cancel a Hire Agreement, they must send notice of cancellation in writing, marked for the attention of the Events Co-ordinator to <a href="mailto:roomhire@cityco.com">roomhire@cityco.com</a></li> <li>Any cancellation will take effect on the day CityCo receives the written notice</li> <li>Cancellation charges will be assessed on a case by case basis</li> <li>Cancellation charges will not apply if cancellation is due to changes in government advice and restrictions</li> </ul>
